

## CONTRACT AGREEMENT

This AGREEMENT is entered to this 27th day of February 2023, by and between:

The **MARITIME INDUSTRY AUTHORITY**, an attached government agency of the Department of Transportation (DOTr) for policy and program coordination, duly created under Proclamation Decree No. 474, with principal address at MARINA Building, Bonifacio Drive corner 20<sup>th</sup> Street, Port Area, Manila City, represented by its Administrator, **Atty. HERNANI N. FABIA**, herein referred to as "**MARINA**";

AND

**AREMOS SECURITY AND INVESTIGATION AGENCY**, a company duly organized and existing under the laws of the Republic of the Philippines represented by its General Manager, **Mr. ANTONIO C. SOMERA**, with principal office address at 8 J. Paredes St., BF Homes Subd., Barangay Holy Spirit, Quezon City, Metro Manila, herein referred to as "**AREMOS**";

**WHEREAS**, the **MARINA** invited bidders for the "Procurement of Security Services for the MARINA Central Office and Satellite Offices for the year 2023";

**WHEREAS**, **AREMOS** submitted its bid and was accepted by **MARINA** for the supply of those goods and services in the sum of **TWELVE MILLION EIGHT HUNDRED EIGHTY FOUR THOUSAND THREE HUNDRED EIGHTY FIVE PESOS AND 12/100 (Php12,884,385.12)** (hereinafter called "the Contract Price").

### **NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. The Contract Period shall be for one (1) year, commencing on January 1, 2023 to December 31, 2023 for Twenty Seven (27) security guards on twelve (12) hours shift to be posted at the Marina Central Office and Satellite Offices.
2. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
3. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) AREMOS's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General and Special Conditions of Contract and;
  - (e) the Supplemental or Bid Bulletins, if any
  - (f) the Performance Security, and
  - (g) the Entity's Notification of Award
4. In consideration for the sum of **TWELVE MILLION EIGHT HUNDRED EIGHTY FOUR THOUSAND THREE HUNDRED EIGHTY FIVE PESOS AND 12/100 (Php12,884,385.12)** or

such other sums as may be ascertained, **AREMOS** agrees to provide the services in accordance with its Bid and Technical Specifications.

5. The **MARINA** agrees to pay the above-mentioned sum in accordance with the Terms of the Bidding.
