Interested parties may secure a copy of this invitation on from the Head Secretariat of the MARINA Disposal Committee whose office is located at the 10<sup>th</sup> Floor MARINA Building, 20<sup>th</sup> St. corner Bonifacio Drive, Port Area.

Please take note that the proposal shall be addressed to **Dir. NENITA S. ATIENZA**, Chairperson, MARINA Disposal Committee and shall be submitted to the Head Secretariat of the MARINA Disposal Committee.

Further, proposals shall be subject to the following terms and conditions, to wit:

1. A bidder/s shall bid on all items of one (1) lot;
2. Bidders are required to enclose / post a Bid Bond in the form of Cash, Cashier, or Manager's Check equivalent to Ten Percent (10%) of the Floor Price. All Bonds of non-winning bidders are refundable immediately after selection of winning bidder. However, the winning bidder's bond shall only be withdrawn upon perfection/ completion of the contract;
3. The Floor Price of the items for sale is **TWELVE THOUSAND PESOS (P12,000.00)**, non-negotiable and on an "As-is-Where-Is" basis;
4. All expenses related to the hauling of these items shall be borne by the Buyer;
5. Date of completion and full payment shall be made not later than three (3) Calendar Days upon issuance of the Notice of Award;
6. Non- compliance of the winning bidder on the above stipulated Terms and Conditions shall be grounds for the rejection of the bid without prejudice to a re-bidding as the situation warrants;
7. Contract of Conveyance shall be executed by the MARINA Administrator as Head of the Agency in favor of the winning bidder immediately after the Notice of Award has been served to the latter; and

8. The Head of the Agency reserves the right to accept or reject any or all bids, waive any defects contain herein, to annul the bidding process and reject all Bids any time prior to Contract Award without thereby incurring any liability to the affected Bidder or Bidders.

Deadline of submission of sealed proposals is on **April 20, 2023** at **12:00 noon**.
