INVITATION TO BID

**PROCUREMENT OF BRAND NEW ONE (1) SPORTS UTILITY VEHICLE FOR
MARINA REGIONAL OFFICE - X**

1. The MARITIME INDUSTRY AUTHORITY, through the FY 2022 General Appropriations Act (GAA) (R.A. 11639 – Continuing Appropriations) of MARINA intends to apply the sum of **One Million Eight Hundred Ten Thousand Pesos (Php1,810,000.00)** inclusive of VAT and all other applicable government taxes, being the ABC. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The MARITIME INDUSTRY AUTHORITY now invites bids for the above Procurement Project. Delivery of the Goods is required within thirty (30) calendar days upon receipt of Notice to Proceed (NTP). Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
 - b. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
4. Prospective Bidders may obtain further information from MARITIME INDUSTRY AUTHORITY and inspect the Bidding Documents at the address given below during 9:00 AM to 4:00 PM.
5. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and at **www.marina.gov.ph**, however, the Bidders shall pay the Bid Documents based on the table below. Proof of payment shall be presented prior to submission of Bids.
