

TERMS OF REFERENCE (TOR)

I. Project Name/Title

Procurement of brand new One (1) Sports Utility Vehicle (SUV) for Maritime Regional Office - X

II. Approved Budget for the Contract (ABC)

The total Approved Budget for the Contract ("ABC") for this procurement is **ONE MILLION EIGHT HUNDRED TEN THOUSAND (₱1,810,000.00)**, inclusive of VAT and all other applicable government taxes to be charged against the FY 2022 General Appropriations Act (RA 11639), Continuing Appropriations.

III. Technical Specifications

IV. BIDDERS QUALIFICATION

The dealer / distributor shall have the following qualifications:

- a. Must be at least five 5 years of operation in the Philippine market.
- b. Must have service centers in Metro Manila, Luzon, Visayas and Mindanao.
- c. Must be PhilGEPS Registered

V. Responsibility of the Dealer / Distributor

1. Conduct of drive test of service vehicles;
2. Warranty card should be turned-over to MARINA on the same date of delivery of vehicles;
3. Provide training of at least one (1) hour on proper operation, maintenance and troubleshooting for the service vehicle at the supplier's cost; and,

4. Provide manuals, hand-outs and other peripherals for service vehicles.
5. After Sales Service and Support during the warranty period, all reported defects shall be immediately completely and full satisfactorily repaired/replaced by the winning bidder/supplier within seventy –two (72) hours after receipt of notification in any form of communication such as but not limited to electronic mail, internet platform, verbal, and or written notices from the authorized MARINA officials and or employees.

VI. Terms of Delivery

1. Delivery within thirty (30) calendar days upon receipt of Notice to Proceed, to be delivered to the MARINA Building, 20th Street corner Bonifacio Drive, Port Area Manila:
2. Delivery should be made within office hours and on regular working days on or before the stipulated date in the contract unless otherwise specified for a valid reason why the same cannot be complied with.

VII. Payment Term

The payment shall be done within forty (40) working days after inspection and acceptance by the MARINA.

VIII. Liquidating Damage

MARINA shall impose a penalty of 1/10 of 1% of the total value of the undelivered unit/s for each day of delay as liquidated damages after specified allowable number of days to deliver the units.

IX. Inspection, Testing and Acceptance

The delivered motor vehicles shall be subjected to visual and functional inspection and testing, acceptance and parameters such as, but not limited to:

- Quantity per item and accessories, if applicable
- compliance to specification (offered vs. delivered)
- functionality such as but not limited to:
 - Engine will start-up
 - Air-conditioning system is working system, if applicable
 - Doors and windows mechanisms are functional.


X. Right of MARINA


