ISSUANCE OF APPLICATION NUMBER PRIOR ENROLMENT

FOR PRACTICAL ASSESSMENT

Pursuant to Republic Act No. 10635 and its implementing Rules and Regulations (IRR) and Republic Act No. 11032 otherwise known as the "Ease of Doing Business and Efficient Government Service Delivery Act of 2018", NOTICE is hereby given on the issuance of APPLICATION NUMBER prior enrolment for Practical Assessment to MARINA Accredited Assessment Centers.

In reference to Section 13 of STCW Circular Nos. 2018-08 and 2018-09, "A candidate shall pass the theoretical examination prior to taking the practical assessment". Upon effectivity of this Advisory, those who shall pass the theoretical examination will automatically receive an APPLICATION NUMBER in their respective MISMO Accounts and a system-generated SMS after their Certificate of Passing is uploaded by the Examination and Assessment Division (EAD) of the STCW Office. Thus, applying for Practical Assessment shall no longer be required.

However, the following shall still need to apply for Practical Assessment through their MISMO Accounts and will not be covered by the above provision:

- 1. Passers prior the effectivity of this Advisory;
- Holders of Certificate of Competency (CoC) for different levels of responsibility who do not meet the required seagoing service and wish to revalidate their COC and opted to take the practical assessment prescribed by the Administration; and
- 3. Those seafarer-applicants who are required to take the assessment prior issuance of the corresponding COPs (Ratings).

In view thereof, all Assessment Centers are hereby directed to check the eligibility of the seafarer-applicants to take the practical assessment by requiring the submission of the following prior accepting to enrolment:

Further, the coding system is enhanced as a measure for the Assessment Centers to easily check the eligibility of seafarer-applicants. Thus, the following Codes shall be adopted:
