## IMO SECRETARY-GENERAL COMMENDS PHILIPPINES FOR ACHIEVING POSITIVE RESULTS IN EVALUATIONS AND INSPECTIONS

The Philippines demonstrated its commitment to fulfilling obligations under Regulation I/8 and Section A-I/8 of the Standards of Training, Certification, and Watchkeeping (STCW) Convention during the IE. Moreover, the European Commission has decided to continue recognizing Philippineissued STCW Certificates, securing employment opportunities for nearly 50,000 Filipino marine officers on European-flagged vessels.

Secretary-General Lim expressed his appreciation for the Philippines' hard work and dedication to these endeavors, emphasizing their positive impact on future development, including adapting to new challenges such as decarbonization.

Engr. Nannette Z. Villamor-Dinopol, the MARINA Deputy Administrator for Operations and head of the Philippine delegation conveyed the country's gratitude to the IMO for their unwavering support during the Independent Evaluation, EMSA Inspection, Ferry Safety Assessment Project, and the GloFouling Partnerships Project. Engr. Dinopol highlighted the significant benefits and strengthening of the Philippine maritime industry through the IMO's cooperation programs, projects, and training initiatives.

and Southeast Asian states, including ASEAN member states, to discuss emission reduction and energy efficiency measures in shipping operations. Key topics included regional perspectives and priorities in the ongoing negotiations of the IMO's strategy on greenhouse gas emissions reduction from ships.

Notable guests in attendance were IMO Secretary-General, His Excellency Kitack Lim; Denmark's Ambassador to the Philippines, His Excellency Franz-Michael Skjold Mellbin; Undersecretary for Legal Affairs of the Department of Transportation (DOTr), Honorable Reinier Yebra; and Undersecretary of Foreign Affairs (DFA), Honorable Jesus Gary Domingo.

Secretary-General Lim emphasized that maritime transport remains the most economically and environmentally sustainable mode for larger cargo volumes. He stressed the need for the shipping sector to embrace the energy transition and attract the next generation of maritime personnel and seafarers through renewable energy and energy efficiency technology.

Ambassador Mellbin highlighted the importance of global dialogue to address the challenges and possibilities of the shipping industry's enormous changes. He emphasized the need for collaboration to achieve climate obligations and solve the climate crisis.

MARINA Administrator Atty. Hernani N. Fabia expressed the conference's objective to mitigate climate change, protect oceans, and ensure seafarers' livelihoods. He called for a sustainable and prosperous future where green shipping becomes the norm.

The two-day conference covered topics such as the IMO regulatory framework, green ports' role in energy efficiency, and technology development. Discussions also included green shipping opportunities, the development of green corridors, the creation of green jobs, the skill development of seafarers, and the value chain of future fuels.

Presentations on maritime solutions and green infrastructure opportunities were featured on the last day. Attendees explored the global pathway toward the shipping sector's green transition and the role of governments in driving the change.

The conference concluded with an interactive session to address key questions on the challenges and opportunities of the green transition in shipping. Participants discussed the roles of governments, private sectors, and the IMO in accelerating the transition.

Climate Change Commission (CCC) Secretary Robert Borje delivered closing remarks, emphasizing the conference's significance to climate change and the country's sustainable development agenda.

The regional conference facilitated knowledge sharing and highlighted concrete steps taken towards greening the shipping sector, showcasing different regional experiences.

## MARINA ENGAGES IN DAP'S ISO 9001:2015 CAPACITY-BUILDING WORKSHOP

Manila – The Maritime Industry Authority (MARINA) participated in the first capacitybuilding intervention organized by the Development Academy of the Philippines (DAP) from 23-26 May 2023.

The workshop focused on ISO 9001:2015 Quality Management System (QMS) requirements and documentation, part of the Government Quality Management Program (GQMP) 2023. DAP, led by Project Team Manager Mr. Ronaldo Armin F. Ocampo, provided technical assistance for the training course.

MARINA welcomed this initiative as it aligns with the Enabling Program of the MIDP 2028, aiming to establish an efficient and effective maritime industry governance system with a focus on good governance and accountability. It also contributes to the goals of Chapter 14 of the Philippine Development Plan 2023-2028, "Practice Good Governance and Improve Bureaucratic Efficiency."

MARINA aims to have all its nationwide services certified under ISO 9001:2028 within the first half of President Ferdinand R. Marcos Jr.'s term. During the event, Nenita S. Atienza, Director of MARINA's Management, Financial, and Administrative Service (MFAS), emphasized the significance of ISO certification for the organization. The training aimed to enhance participants' knowledge of quality concepts, ISO 9001 standards, and relevant statutory and regulatory requirements.

# MARINA ASSESSES PASSENGER SERVICE QUALITY AND GENDER DEVELOPMENT IN DOMESTIC SHIPPING



Manila - The Maritime Industry Authority's Domestic Shipping Service (MARINA-DSS) recently completed its second round of surveys for the Passenger Service Rating System – Gender and Development (PSRS-GAD). The evaluation took place from 8-10 May 2023.

Led by Atty. Patrick D. Ferraro, the DSS team conducted surveys on two vessels, MV FastCat M15 and MV Isla Simara, which operate routes from Batangas to Calapan, Oriental Mindoro, and vice versa, including Puerto Galera. The PSRS-GAD serves as a monitoring and rating system for assessing service standards provided to passengers on domestic liner and ferry ships. It ensures compliance with Accessibility Law and government gender development policies within the domestic shipping industry.

The survey evaluated various aspects of service, such as ticketing systems, service adequacy, boarding procedures, baggage handling and security, passenger accommodations, crew, and gender development-related issues. The results will be shared with ship owners and operators.

# MARINA ENHANCES SKILLS WITH KONGSBERG DIGITAL'S 4-DAY SIMULATION WORKSHOP

Manila - The evaluators of the Maritime Industry Authority's (MARINA) STCW Office are currently undergoing a 4-day simulation workshop conducted by Kongsberg Digital. The workshop aims to support the agency's ongoing development efforts and address key areas and issues related to the European Union's extension of recognition to the Philippines' STCW System.

The workshop commenced with an opening program led by Capt. Vicente C. Navarro, Deputy Executive Director of the STCW Office, and VADM Eduardo Ma R Santos AFP (Ret), President of the Maritime Academy of Asia and the Pacific (MAAP) and Kongsberg Users Philippines, Inc. (KUPI). Participants include Maritime Education and Training Standards Supervisors (METSS), Monitoring Division personnel from the STCW Office, and Kongsberg simulation specialists from the Philippines and the Asia-Pacific region.

Renowned experts and industry leaders are facilitating the workshop, covering practical training techniques, regulatory compliance, industry standards, and advancements in maritime education technology, including cloud-based maritime simulators. The workshop is delivered in collaboration with DNV, PCI/Seaversity, and Integrated Maritime Practical Assessment Center and Technical Solutions (IMPACTS), in line with MARINA's commitment to fostering partnerships and collaboration within the maritime sector.

The simulation workshop focuses on training facilities, simulators, monitoring, supervision, and evaluation of training and assessment. It provides participants with a valuable platform to expand their knowledge and expertise in maritime education. This series of workshops underscores the dedication of all involved parties to stay at the forefront of maritime education advancements and ensure the continuous enhancement of industry standards.

# PHILIPPINES TAKES LEAD IN ASEAN MEETING, SHARES INITIATIVES TO COMBAT MARINE LITTER

Da Nang City, Viet Nam - The Philippines, represented by the Maritime Industry Authority (MARINA), showcased its dedication to sustainable shipping during the 44th ASEAN Maritime Transport Working Group (MTWG) Meeting from 9-11 May 2023.

Led by Engr. Nannette Z. Villamor-Dinopol, MARINA's Deputy Administrator for Operations, the Philippine delegation highlighted the collaborative efforts between MARINA and the World Wide Fund - Philippines. Following the comprehensive MBST, a licensing examination was administered to 25 applicants, including 16 Boat Captains Class 1 (BC1) and 9 Motor Men. Successful completion of the examination would result in the issuance of their Certificate of Marine Profession (CMP), recognizing them as certified maritime professionals.

These initiatives reflect the commitment of the MARINA Regional Office XI in promoting safety and proficiency in the maritime industry. By providing training and licensing opportunities, the MRO11 contributes to the development of maritime practices in Davao Oriental, fostering a culture of excellence and professionalism in the local maritime community.

## MARINA ENHANCES SAFETY TRAINING FOR SEAFARERS AND CONDUCTS MOBILE SERVICES



The Maritime Industry Authority (MARINA) has been actively working to promote safety and enhance services in the maritime industry. In two separate initiatives, MARINA Regional Office V (MRO5) conducted a successful two-day Modified Basic Safety Training (MBST) for seafarers, while MARINA-National Capital Region (MARINA-

NCR) launched mobile services for registration, licensing, documentation, and franchising of fishing and passenger carrying wooden-hulled ships.

In Legazpi City, MRO5 organized the MBST on 25-26 May 2023, aiming to improve the safety knowledge and skills of seafarers operating Philippine registered vessels below 35GT. The training gathered 43 participants from various provinces, including Albay, Camarines Sur, Camarines Norte, Sorsogon, and Masbate. Boat Captains and Motormen underwent comprehensive instruction on basic safety procedures and practices, equipping them with essential knowledge for safe maritime operations.

Meanwhile, MARINA-NCR, under the leadership of Regional Director Engr. Marc Anthony P. Pascua, initiated the Mobile Basic Safety Training and Mobile Registration, Licensing, Documentation, and Franchising of Fishing and Passenger Carrying Wooden-Hulled Ships on May 9, 2023. This joint effort involved MARINA-NCR, Bureau of Fisheries and Aquatic Resources (BFAR) - Region III, National Telecommunications Commission (NTC) - Region III, and Philippine Coast Guard (PCG) - Dingalan. The initiative, conducted in coordination with the LGU of Dingalan, Aurora, led by Mayor Shierwin H. Taay, aimed to bring essential services closer to the fishing and passenger vessel operators, ensuring convenient access to registration, licensing, documentation, and franchising services.
