
# **The Philippines**

We maintain strong bilateral relations with Member States on the **recognition of Certificates of Competency and Issuance of Endorsements** pursuant to Regulation 1/10 of the STCW Convention.

We are the **first Member State** recognized by the ILO to have fully complied with the international requirements of the **Seafarers' Identity Documents Convention** (ILO Convention No. 185).

We are a **member of the Joint ILO and IMO Tripartite Working Group** to identify and address seafarers' issues and the human element.

Transitioning to green shipping, we take the lead on various IMO long-term projects, such as:

The **GEF-UNDP-IMO GloFouling Partnerships Project,** through multilevel interventions in governments and private organizations, collaborating with key partners with the aim to protect marine ecosystems from the negative effects of invasive species.

The **IMO-Norad**, through the Marine Environment Protection for Southeast Asia Seas (MEPSEAS), enhances the capacity of countries involved in the implementation of high-priority marine environment conventions with focus on the effective implemenation of the IMO treaties.

The **GloMEEP** seeks to reduce greenhouse gas emissions from shipping and supports the Philippines to implement measures through (1) legal policy and institutional reforms; (2) maritime sector energy efficiency capacity building, awareness raising, knowledge creation, and dissemination; (3) public-private partnerships to catalyse maritime sector energy efficiency innovation, research & development, and technology deployment.

### Enabling programs to push both core and overriding programs forward

Adoption and implementation of an effective and efficient maritime administration governance system

The Maritime Industry Development Plan 2028 (MIDP 2028) envisions a robust, stable, and upgraded Phiippine merchant marine fleet meeting national and global standards together with advancements in maritime human capital. The MIDP 2028 is anchored and aligned with the UN Sustainable Development Goals, AmBisyon Natin 2040, Philippine Development Plan 2023-2028, and other laws on gender and development, accessibility, ease of doing business, and other affiliated policies.

The Study on the enhancement of safety (FSA-P) and energy efficiency (ENV-P) of domestic passenger ships aims to identify gaps in safety, energy efficiency, and decarbonization in shipping and to provide a path to a sustainable maritime environment linking more than 7,100 islands in the archipelago.

The National Strategic Action Plan under Green Maritime Philippines: Protect and Conserve, is the country's road map in the implementation of IMO Conventions on the protection of marine envionment.

■ Anti-Marine Plastic Litter aims to reduce, and prevent plastic pollution from ships and ports; a partnership between MARINA and the World Wide Fund for Nature-Philippines

■ Green Port Initiatives aims to reduce greenhouse gas emissions, air and marine pollution, and wastes, while actively engaging with stakeholders; also a partnership between the Philippine Ports Authority and the World Wide Fund for Nature-Philippines
