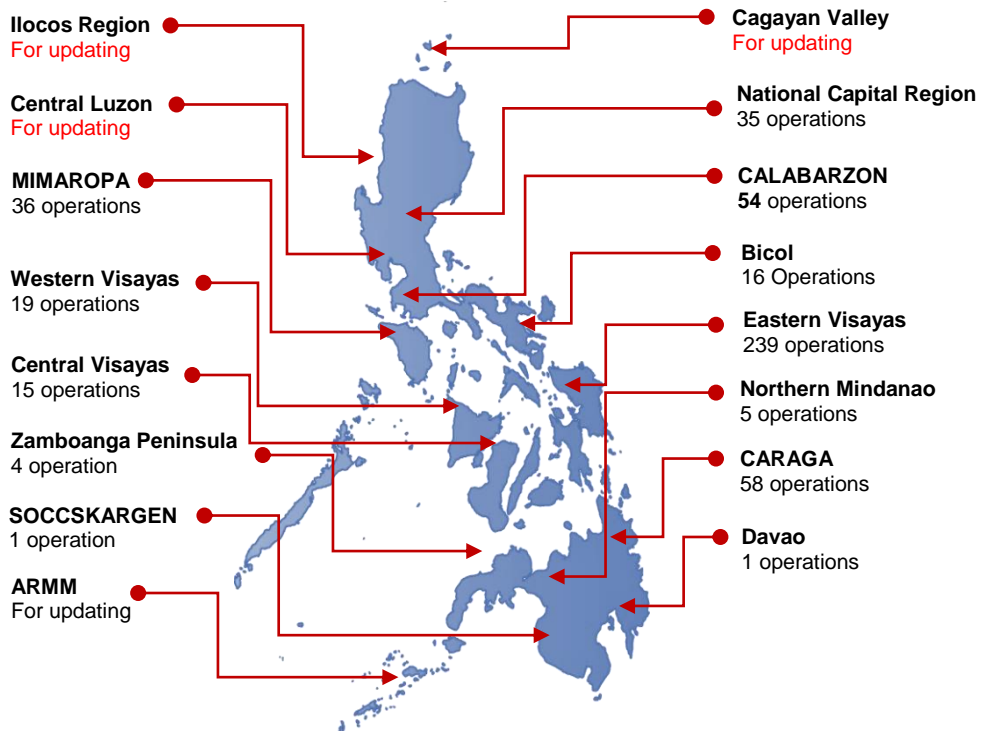
HIGHLIGHTS

- Ninety-six percent (96%) of passenger and cargo shipping operations were completed in accordance with the ships' CPC.
- Four percent (4%) of the shipping operations were affected.
- Operations of passenger ships were more affected compared to cargo ships. 100% of the cargo shipping operations were completed under normal conditions compared to passenger ships at 92%.
- Daily average passenger and cargo ship operations are 116 completed under normal conditions, 0 cancelled trips, 5 delayed and 0 not completed voyage.
- **With cargo shipping still operational, transport of goods is assured.**

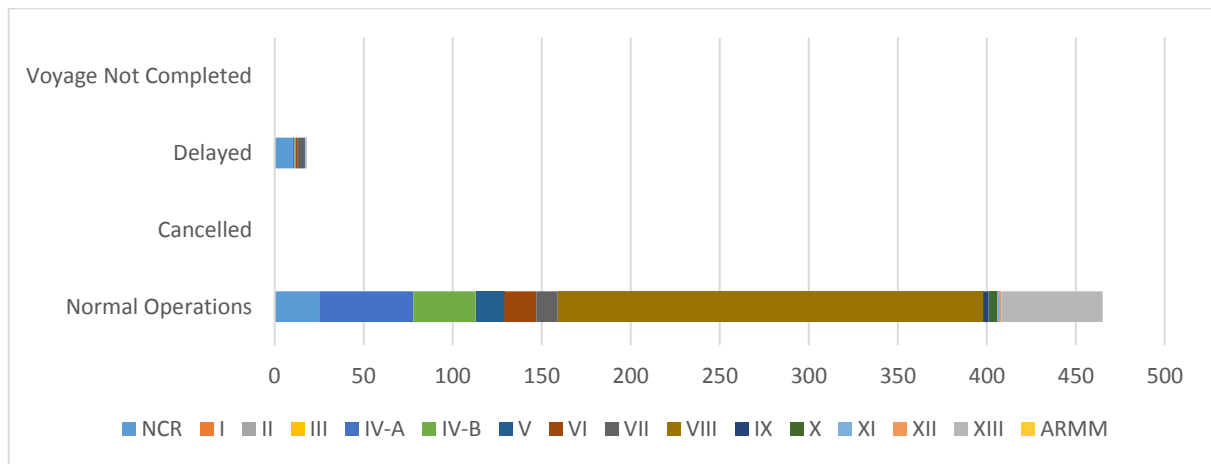

I. STATUS OF SHIPPING OPERATIONS NATIONWIDE



On Jan. 20 - 26, 2023, there were 483 passenger and cargo shipping operations conducted wherein 465 or 96% were completed in accordance with their Certificate of Public Convenience (CPC).

Out of the 465 operations completed under normal conditions, the reported movements were mostly in the Eastern Visayas Region at 51% and CARAGA Region at 12%.

Eighteen (18) passenger ships or 8% encountered delays.

No shipping operations were not completed at the time of reporting, as the respective ships were still underway.

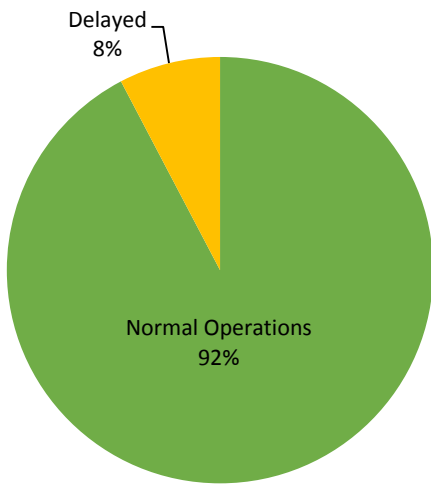

Amid the measures in place due to MGCQ, and GCQ, 249 out of 249 (100%) cargo ships still operated normally – are 41 container ships, 12 general cargo ships, 32 LCT ships, 164 Roro cargo ships.

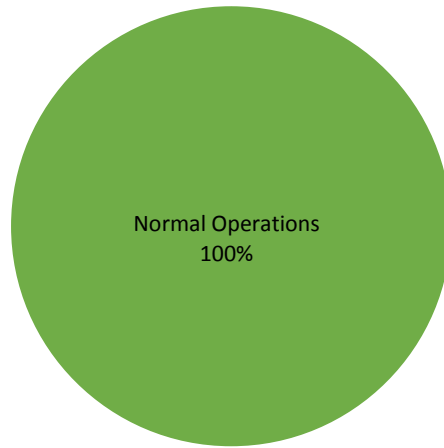
Two hundred and sixteen (216) passenger ships completed their voyage – 144 conventional passenger ships, 47 RoPax ships and 25 fast craft ferry completed their operations but mostly only carried cargoes during their voyage.

Meanwhile out of the 234 passenger ships, 8% were affected by the measures adopted in view of COVID-19. These measures caused either the cancellation, delay, or uncompleted operations of 18 passenger ships.

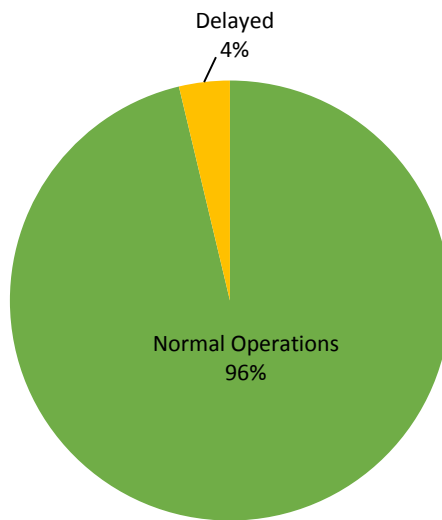
PASSENGER Ship Operations



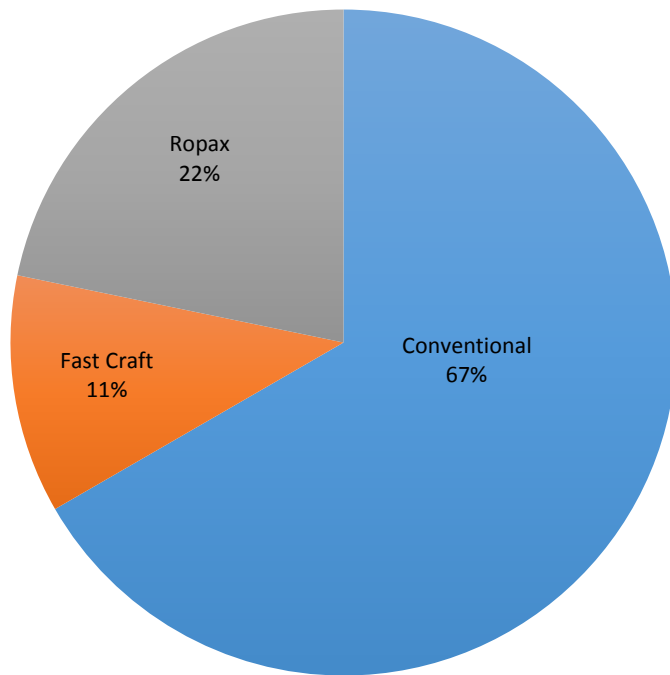
CARGO Ship Operations



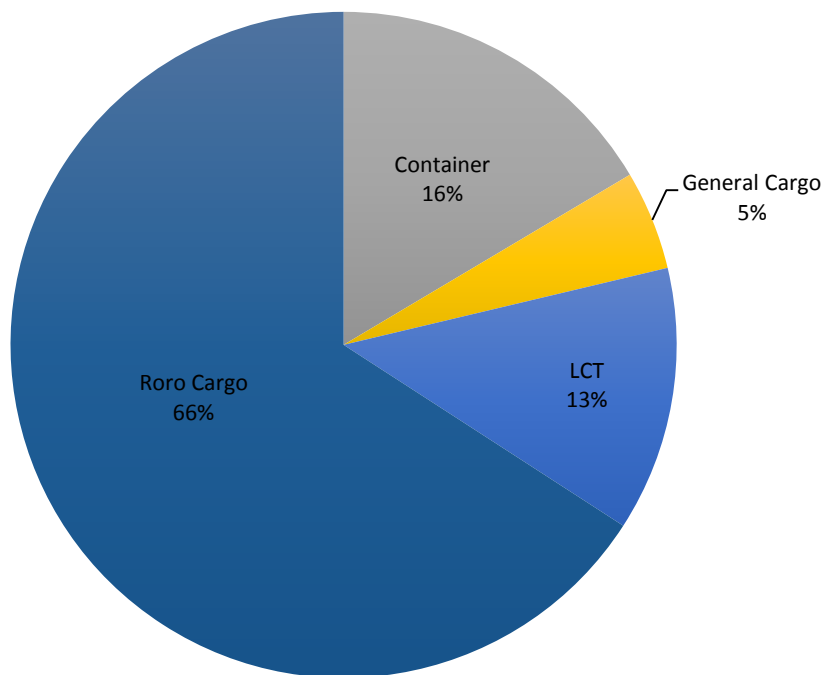
PASSENGER and CARGO Ship Operations



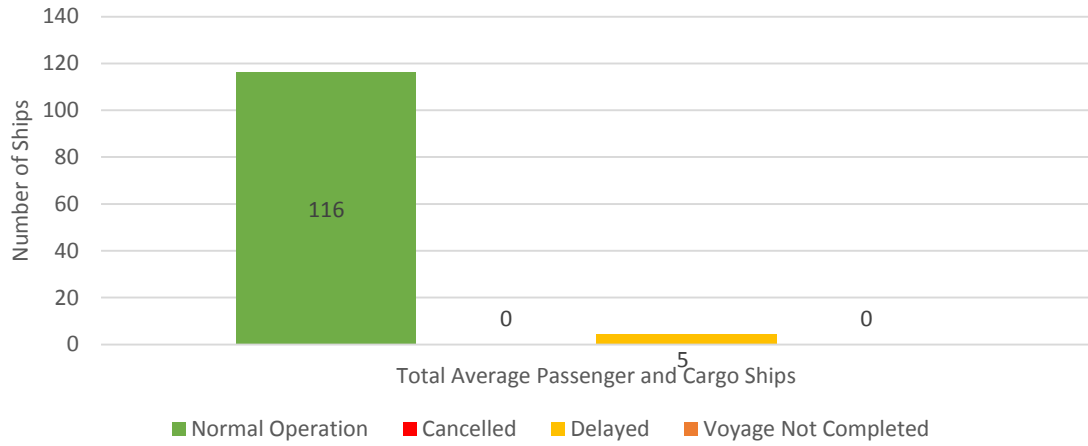
Passenger Ship Types under Normal Operations



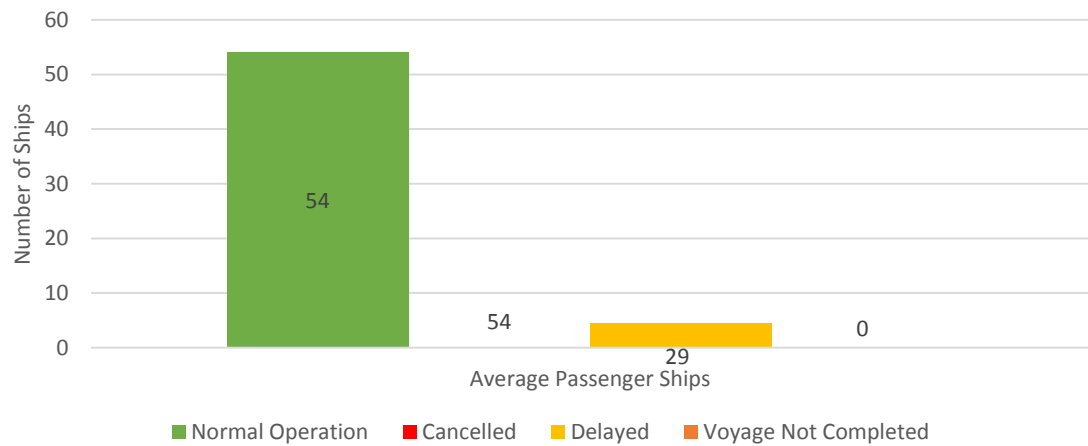
Cargo Ship Types under Normal Operations
