  - Applicants for Competency Assessor who are affiliated with any ACs and are performing as an assessor of level/s of responsibility, evidenced by ROA issued within the validity of his/her COA as Assessor, will not be required to undergo Competency Assessor Orientation conducted by the BOE.
  - Applicants for Competency Assessor who are affiliated with AC/s and with experience as an assessor of level/s of responsibility, but with expired COA as an Assessor under STCW Circular No. 2014-04 for more than one (1) year shall be required to undergo Competency Assessor Orientation, in addition to revalidation requirements of this Circular.
- The qualification requirements in this Annex may be revised in subsequent amendments and shall be implemented without the re-issuing the Circular.
