WITH THAT BEING SAID, I WOULD LIKE TO CONGRATULATE EVERYONE FOR BEING HERE TODAY AND FOR THE OPPORTUNITY TO LEARN MORE ON SHIPBUILDING TECHNOLOGY, MARITIME SAFETY, MARINE ENVIRONMENT PROTECTION, DIGITALIZATION AND OTHER RELATED MATTERS, WHICH CONTRIBUTE A LOT IN TERMS OF SUSTAINING THE DEVELOPMENT OF THE MARITIME INDUSTRY.

AS YOU ALL KNOW, THE MARINA IN COORDINATION WITH OUR AGENCIES AND PRIVATE PARTNER STAKEHOLDERS SPEARHEADED THE UPDATING OF THE MARITIME INDUSTRY DEVELOPMENT PLAN (MIDP) 2028 THAT WAS ADOPTED THROUGH THE ISSUANCE OF EXECUTIVE ORDER NO. 55. THE MIDP 2028 COVERS A CORE PROGRAM ON "MODERNIZATION, EXPANSION AND PROMOTION OF THE PHILIPPINE SHIPBUILDING AND SHIP REPAIR INDUSTRY." WHICH AIMS TO MODERNIZE AND EXPAND THE PHILIPPINE SHIPYARDS' CAPABILITY AND CAPACITY TO NOT ONLY MEET THE DEMANDS OF THE LOCAL AND INTERNATIONAL SEA TRANSPORT MARKET, BUT ALSO CREATE MORE JOBS AND INCREASE INVESTMENTS IN THE COUNTRY.

THE SAID MIDP CORE PROGRAM AND THE ASSESSMENT REPORT OF MARINA STATE THAT LOCAL SHIPYARDS HAVE THE CAPABILITY AND CAPACITY TO CONSTRUCT SHIPS FOR DOMESTIC USE UP TO 1,000 GROSS TONS ON THE AVERAGE. ²

WE, IN MARINA, OUR WORKING VERY HARD TO ENSURE THAT THE PLANS IN THE MIDP 2028 WILL NOT ONLY REMAIN PLANS BUT BE TRANSLATED INTO ACTIONS, GIVING US OUR EXPECTED POSITIVE OUTCOMES.

THE MARINA ALSO RECOGNIZED THE IMPORTANCE OF THE RESOLUTION THAT WAS SIGNED DURING THE 3RD NATIONAL SHIPYARDS CONVENTION LAST APRIL 2024, WHICH FOCUSES ON LEGISLATION, RESEARCH AND DEVELOPMENT, CAPABILITY AND CAPACITY AND SBSR WORKFORCE.

IN TERMS OF THE EMERGING TECHNOLOGIES, WE RENEWED OUR PARTNERSHIP WITH THE DEPARTMENT OF SCIENCE AND
