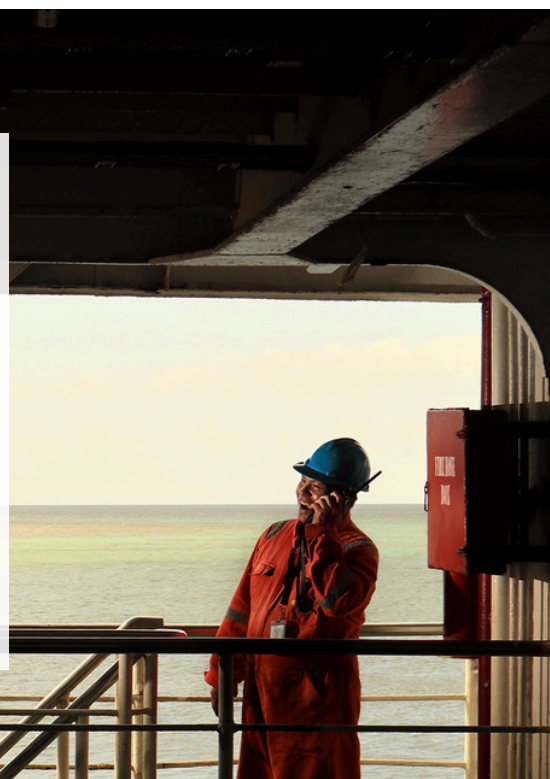

## MARINA welcomes first-ever resolution in the human rights ...

Accordingly, the resolution acknowledges that seafarers brave challenging conditions at sea that pose risks to their enjoyment of human rights, safety, and well-being. Seafarers conduct their duties, even at times under dangerous conditions.

This resolution affirms that safe and decent living and working conditions at sea is a human rights imperative, and calls for stronger collaboration between States, shipowners' representatives, seafarers' representatives, the International Labor Organization, the International Maritime Organization, non-governmental organizations and other stakeholders to uphold and protect the rights and dignity of all seafarers around the world.

With this development, the MARINA commends the efforts of the Department of Foreign Affairs (DFA) through the Philippine Mission in Geneva for leading this initiative that seeks to promote and protect the enjoyment of human rights by seafarers.

As the largest single source of certificated seafarers, the Philippines stands to benefit from this Resolution which has a total certificated seafarers of 798,309 as of 30 June 2024.

The MARINA will continue to engage various fora to sustain the government's campaign to ensure the realization of the intent of this first ever UNHRC Resolution for seafarers.

## MARINA, PCG Hold Forum on Maritime Safety...

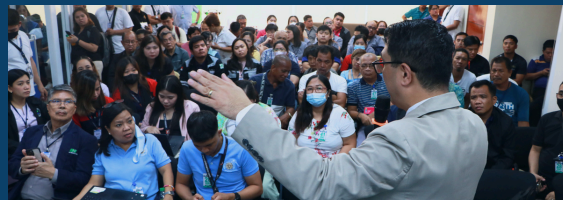

## MARINA Launches Blockchain ...



The new system will allow applications to be processed instantly and accessed via web or mobile platforms, utilizing electronic certificates and licenses. This initiative is part of MARINA's broader push towards digitalizing its services.

"The MARINA BEST will automate our core processes, providing online access to the system, online tracking of transactions, and online payment, while ensuring data security and protection," MARINA Administrator Sonia B. Malaluan said during the launch.

The project is a collaborative effort involving various MARINA offices and external partners, underscoring the agency's commitment to innovation and progress. It also aligns with the updated Maritime Industry Development Plan (MIDP) 2028, which aims to implement sustainable maritime innovation and transformation.

"This is more than just a technological upgrade – it's a testament to our commitment to excellence, innovation, and progress," the Administrator added.

The MARINA BEST is expected to set a new standard for efficiency, security, and accessibility in maritime services.

CG Vice Admiral Joseph M. Coyne, leading the PCG delegation and representing PCG Commandant Ronnie Gil Latorilla Gavan emphasized that this forum is a crucial platform for aligning communication between the two agencies to effectively share vital information on maritime topics and incidents.

During the forum, the MARINA and PCG presenters discussed various topics, including the MARINA Circulars, maritime safety, the conduct of vessel safety enforcement inspections, maritime incident communication and reporting procedures, the safety, security, and environmental numbering management database system, and the conduct of salvage vis-à-vis ship breaking.

Officials of both MARINA and PCG agreed to conduct similar forum regularly.

The event concluded with closing remarks from Engr. Ronaldo P. Bandalaria, who highlighted the crucial need for close collaboration with the Philippine Coast Guard. This forum is part of the MARINA Administrator's Ten-Point Agenda, particularly Item No. 5, which emphasizes the importance of forging strong partnerships with the PCG and other.



# MARINA Lawyers Convene to Advance Maritime Industry Development



CLARK, PAMPANGA - MARINA lawyers from across the Philippines gathered for the 2024 MARINA Lawyers' Convention that focused on drafting the administrative versions of key maritime bills, particularly, the Philippine Ship Registry Bill and the Shipbuilding and Ship Repair Development Bill. The session aimed to develop a new strategy for legislative

advocacy, a vital element in promoting these bills in Congress.

In her opening address, MARINA Administrator Sonia B Malaluan emphasized the importance of celebrating achievements,

committing to future tasks, and maintaining accountability. She highlighted that it is a critical period for the maritime industry, pointing to recent trends such as green shipping, decarbonization, and the use of advanced technology in shipyards. Malaluan also reiterated MARINA's commitment to supporting local shipbuilders in maximizing digital technology opportunities while ensuring proper regulation.

The workshop concluded with significant progress in legislative drafting, and participants pledged to apply their new insights to their respective roles.

## MARINA Enhances Project Monitoring and Evaluation Skills of Personnel

MANILA CITY - The Maritime Industry Authority (MARINA) has partnered with the Development Academy of the Philippines (DAP) to conduct a four-day "Basic Course on Project Monitoring and Evaluation" from 02 July to 05 July 2024.

The training aims to equip MARINA personnel with essential knowledge and skills for effective project monitoring and evaluation. The course covered the project lifecycle, including initiation, planning, execution, regulation, evaluation, and closure.

In her address, MARINA Administrator Sonia Malaluan emphasized the need for the agency to focus on significant, implementable, and achievable projects aligned with the updated Maritime Industry Development Plan 2028 and its strategic plans. "These projects should result in substantial outcomes and transform the maritime industry," she said.

Planning and Policy Service (PPS) Director Luisito U. Delos Santos underscored the importance of developing comprehensive project proposals. "Each proposal should include a complete framework, detailed budget, thorough implementation plans, and effective monitoring and evaluation



mechanisms to ensure the successful execution and sustainability of MARINA's projects and initiatives," he stated.

DAP Sustainable Human Development Program Director Dorothea C. Boy-Navarro highlighted the training's role in ensuring excellence and accountability in delivering projects and programs that benefit the Filipino people.

The training stressed the importance of robust monitoring and evaluation processes and tools, which are crucial for tracking and assessing the progress and effectiveness of MARINA's projects, programs, and policies.

## MARINA Offers Support to Seafarers Affected by Attacks in the Red Sea, other areas

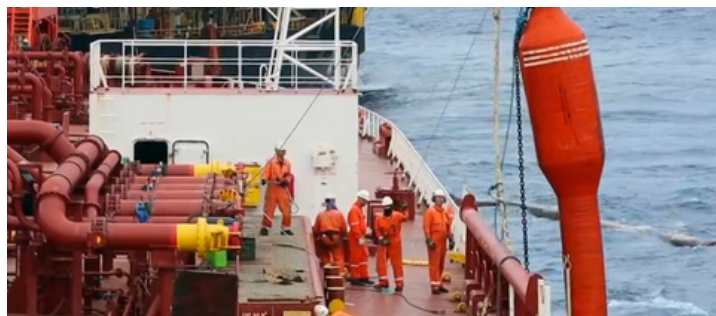
MANILA CITY -The Maritime Industry Authority (MARINA) has laid out assistance to seafarers adversely affected by recent attacks at sea, Administrator Sonia Malaluan stated during a media briefing on 04 July 2024.

"I have directed our STCW Office and regional offices to reissue all documents without any requirements or fees. This will ensure that once seafarers recover from the trauma and are ready to return to sea, they have the necessary credentials," Malaluan said.

In addition, the Administrator revealed that MARINA will appeal to the international community in urging shipping lines to avoid passing through conflict zones such as the Red Sea and Gulf of Aden, following several attacks by Houthi rebels.

"Hindi pwedeng tapatan ang buhay ng tao. It might be costly to pass through another route, it may take an additional 22 days to go around, but still, we are ensuring that we are not putting the lives of seafarers at risk," she emphasized.

MARINA also expressed support for the implementation of a



policy by the Department of Migrant Workers (DMW) which grants Filipino seafarers the option to avoid boarding ships that are passing by high-risk areas or warzones.

Since last year, at least four ships with Filipino crew onboard have already been attacked, with at least two Filipino seafarers killed, 17 held hostage, and one still missing.

The Philippines is the world's top producer of seafarers, with around 570,000 Filipino seafarers deployed worldwide.

# MARINA Hosts 191st Maritime Forum to Strengthen Inter-Agency Collaboration

The Maritime Industry Authority (MARINA) hosted the 191st Maritime Forum at the MARINA Board Room in Manila City on 23 July 2024.

The Maritime Forum is a monthly activity organized by the Maritime League that is aimed to enhance inter-agency cooperation for the betterment of the country's maritime industry by discussing topics beneficial for its advancement through improved collaboration among stakeholders in both government and the private sector.

In his opening remarks, Vice Admiral Eduardo Ma R Santos thanked MARINA for its active involvement and highlighted the significance of discussing pending bills and digitalization in the maritime sector. "There's a need for us to strengthen our maritime industry to contribute towards the success and development of our country," he stated.

MARINA Administrator Sonia Malaluan expressed her gratitude to the Maritime League for creating a platform to address key maritime issues. "This monthly forum provides a valuable opportunity for government agencies and private maritime stakeholders to address concerns related to maritime development, safety, security, marine environment protection, and improvements in shipbuilding and repair," she noted.

The forum featured several important presentations: Dr. Joseph Victor S. Generato, Director of the Management Information Systems Service, introduced the MARINA BEST Digitalization Project. Atty. Sharon D. Aledo, Director of Legal Service, updated attendees on major pending bills related to ship registry. Atty. Daniel Martin G. Oral, Division Chief of the Prosecution Division in the Legal Service, provided insights into shipbuilding development bills.



Following these discussions, an open forum allowed participants to seek clarification and discuss various issues related to the presentations.

Ms. Blanca Joy Bustamante, President of Intellevision Events Philippines, concluded the forum by sharing details about the upcoming Maritime League Beacon Expo and Conference, scheduled for 30 September to 2 October 2024 at the SMX Convention Center in Pasay City.

Since 1990, the Maritime League has been committed to advancing the maritime sector's interests and promoting maritime safety and industry development through regular forums and other communication efforts.

## Philippines Highlights Need for IMO Technical Assistance at III 10 Session, Supports New Maritime Safety Proposals

London, United Kingdom— The Philippines emphasized the significance of technical assistance from the International Maritime Organization (IMO) in improving the implementation and enforcement of mandatory IMO instruments during the 10th Session of the Sub-Committee on Implementation of IMO Instruments (III 10), held from 22-26 July 2024.

The Philippines praised the methodology presented by the IMO for analyzing Consolidated Audit Summary Reports (CASRs) and expressed hope that the study's findings would help prioritize technical assistance for member states. This assistance aims to address recurrent issues identified during recent IMO audits in the Philippines and support member states in meeting their obligations under mandatory IMO instruments.

In addition to supporting the approval of the draft text of "Lessons Learned" from marine casualties for publication on the IMO website, the Philippines backed a proposal to expand Automatic Identification System (AIS) and Very High Frequency (VHF) carriage requirements to domestic vessels, including fishing boats. The delegation also announced that the Philippines will host the 24th session of the Marine Accident Investigators' Forum in Asia (MAIFA 24) in Boracay Island, Province of Aklan, from September 4 to 6, 2024.

The Philippine delegation was led by Atty. Ana Marie L. Hernando, Alternate Permanent Representative in London, with representatives from the Maritime Industry Authority (MARINA), Philippine Coast Guard (PCG), Cebu Port Authority (CPA), and others participating both in-person and remotely.





# MARINA Highlights PHL Seafaring Sector Updates, Progressive Initiatives at APEC SEN Workshop

The Philippines, represented by the Maritime Industry Authority (MARINA), highlighted significant updates on its seafaring sector, as well as its forward-looking initiatives, at the APEC SEN Workshop on Maritime Transportation Workforce Advancement Policies.

The two-day virtual workshop, held from 10-11 July 2024, features presentations from member economies, focusing on sharing maritime workforce statistics, discussing best practices in maritime education and training systems, highlighting women's capacity building in the maritime sector, and exploring strategies to address emerging transportation challenges.

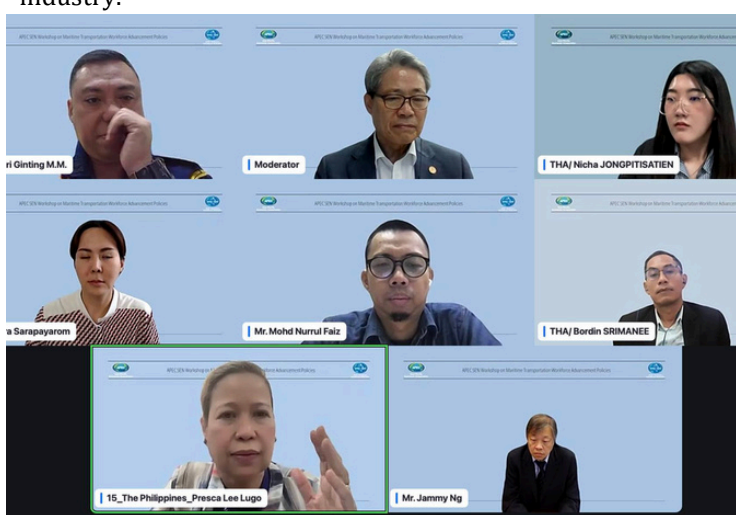
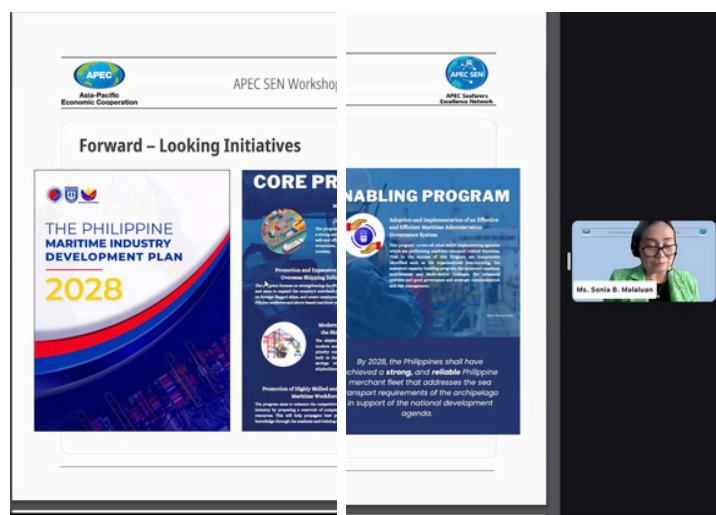
Featuring distinguished speakers from 12 member economies, this workshop aims to encourage participation from government officials, policymakers, and stakeholders, building on existing APEC initiatives and fostering cross-fora collaboration between maritime transportation and gender equality stakeholders.

MARINA Administrator Sonia B. Malaluan presented the country's updates focusing on the current state of seafarers, partnership status with other countries on the mutual recognition of seafarers' certificates, methodologies for database establishment, maritime education and training

systems, and challenges and initiatives for emerging transportation technologies and practices. Administrator Malaluan shared data on the country's issuance of STCW certificates to Filipino seafarers by levels of responsibilities and gender. She also noted the number of IMO Member States recognizing the STCW certificates issued by the Philippines. Information on MARINA's registry and certification for Filipino seafarers and updates on maritime education and training policies were also provided.

"Mindful of the immense impact of maritime emerging technologies and the ongoing comprehensive review of the STCW Convention, which will have long-lasting implications and surely change the way the shipping is conducted for the foreseeable future, the MARINA shall be more active than ever in participating in regional and international dialogues and discussions to protect the rights and promote the welfare of seafarers," Administrator Malaluan emphasized in her presentation.

In its commitment to ensuring a just transition, the MARINA emphasizes the importance of working closely with regional and international partners to navigate the challenges and opportunities presented by the rapidly evolving maritime industry.

# MARINA Capacitates its Technical Personnel on Load Line Assignment of Ships

LEGAZPI, ALBAY- With the aim of capacitating its surveyors, the Maritime Industry Authority (MARINA) conducted the Four (4) - Day Training on Load Line Assignment of Ships on 23-26 July 2024.

The said training, organized by the Shipyards Regulation Service (SRS) in coordination with Bureau Veritas (BV) and hosted by the MARINA Regional Office V, is a course training for Naval Architects, marine engineers and other MARINA technical personnel to have a uniform understanding and interpretation of MARINA Circular No. 2021-02 and some provisions of International Convention on Load Lines of 1966 as modified by 1988 Protocol, as amended, specifically in the computation of load line assignment and procedure of survey.

In her opening remarks, MARINA Deputy Administrator for Operations Engr. Nannette Villamor-Dinopol mentioned that load line marking is just as crucial as the structural integrity

of a vessel. She said that it does not only indicates that a vessel has sufficient reserve buoyancy but it also serves as a prerequisite for calculating the ship's stability.

Meanwhile, MARINA Administrator Sonia Malaluan highlighted the importance of consistently applying load line regulations to ensure safety and stability of ships while at sea. The administrator likewise emphasized the responsibility of MARINA surveyors/naval architects and reminded them to do their work properly and diligently, without compromising integrity.

The Load Line training was facilitated by SRS Director Engr. Ramon Hernandez, Mr. Ji "Jimmy" Ye from Bureau Veritas, French Maritime Expert Mr. Emeric Faure and SRS Division Chief Engr. Ernesto Caluza. It was also participated by MRO V Director Atty. Maximo Bañares Jr. and MARINA Training Institute Director 2nd Mate Louie Lloyd Lamprea.

A total of 65 trainees from various parts of the Bicol Region, including Albay, Masbate, Sorsogon, Catanduanes, Camarines Sur, and Camarines Norte (ALMASOR-CCC), completed the training. The MBST is a prerequisite for the issuance of the Seafarer's Identification Book (SIB), Certificate of Marine Profession (CMP), and License ID.

The training aimed to enhance the safety knowledge and skills of seafarers operating Philippine-registered vessels below 35GT by covering essential maritime modules such as Elementary First Aid (EFA), Personal Survival Techniques (PST), Fire Prevention and Fire Fighting (FPFF), Personal Safety and Social Responsibilities (PSSR), and Typhoon Awareness.

The activity also focused on improving participants' capabilities and effectiveness in their roles as Boat Captains and Motormen.

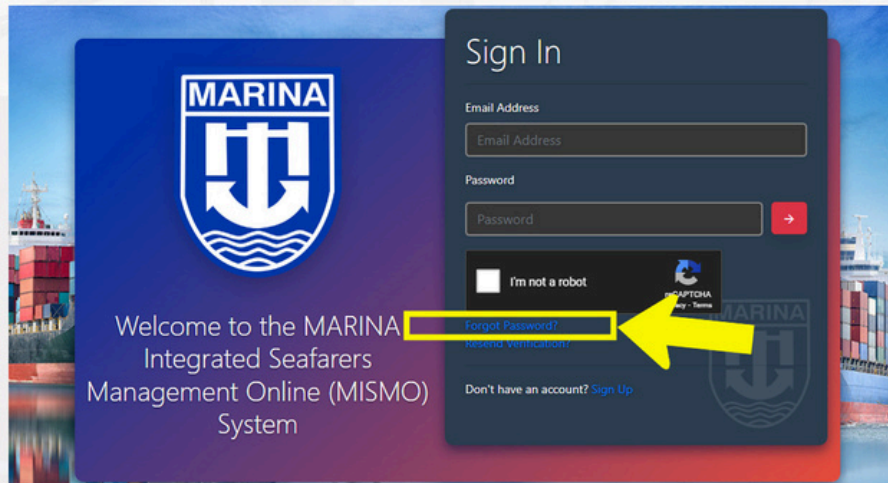
