THE PHILIPPINES HAS A LONG HISTORY AS A MARITIME NATION AND ARCHIPELAGIC COUNTRY THAT HEAVILY RELIES ON MARITIME TRANSPORT FOR ITS DOMESTIC CARGOES.

ARCHEOLOGICALLY, AS EARLY AS 4TH CENTURY, THE EARLIEST BOAT PLANKS WERE RECOVERED IN A PHILIPPINE SITE. 1

HOWEVER, THE 10TH CENTURY REVEALS MORE SIGNIFICANT ACTIVITY FROM HISTORICAL SOURCES AND LIKEWISE CORRESPONDS TO THE PERIOD OF THE EARLIEST WRITTEN RECORD IN THE PHILIPPINE HISTORY; AND IT IS ALSO THE PERIOD OF THE FIRST RECORD OF A SHIP FROM THE PHILIPPINES GOING TO CHINA FOR TRADE.

IN THE YEAR 1565 TO 1815, THE MANILA BECAME ONE OF THE MOST IMPORTANT CITIES AS THE "MANILA GALLEONS" WERE CONSIDERED AS SPANISH TREASURE SHIPS, WHICH TRANSPORTED GOODS FROM MANILA, PHILIPPINES TO ACAPULCO, MEXICO. ² GALLEONS CONTINUED TO BE SIGNIFICANT UNTIL THE STEAM SHIPS WERE TRANSPORTED TO THE COUNTRY BY 19th CENTURY.

AS SHIPS STARTED TO MODERNIZE, THE GOVERNMENT CREATED AN AGENCY MANDATED TO DEVELOP, REGULATE AND PROMOTE THE MARITIME INDUSTRY, AND THAT'S THE BIRTH OF THE MARITIME INDUSTRY AUTHORITY (MARINA) IN 1974 PURSUANT TO PRESIDENTIAL DECREE NO. 474, WHICH PROVIDES FOR THE ATTAINMENT OR THE OBJECTIVE TO, FOR THE GOVERNMENT TO INCREASE PRODUCTION AND PRODUCTIVITY IN THE VARIOUS ISLANDS AND REGIONS OF THE ARCHIPELAGO THROUGH THE PROVISION OF EFFECTIVE SEA LINKAGE.

WE HAVE ALSO STARTED THE DIGITALIZATION OF THE AGENCY'S FRONTLINE SERVICES, WHICH IS CRUCIAL IN PROMOTING EASE OF DOING BUSINESS AND IMPROVING THE DAILY OPERATIONS OF ALL MARINA UNITS NATIONWIDE.




