The Philippines, through the Maritime Industry Authority (MARINA), secured key leadership positions during the 6th APEC Seafarers Excellence Network (SEN) meetings held from September 9 to 11, 2024. Two MARINA representatives were chosen as Vice Chairs for the upcoming 2025-2026 term, solidifying the Philippines' commitment to enhancing maritime standards across the Asia-Pacific region.

Ms. Presca Lee B. Lugo, Maritime Education and Training Standards Supervisor at MARINA's STCW Office, was appointed Vice Chair of the APEC SEN Steering Council, while Mr. Herbert V. Nalupa was selected as Vice Chair of APEC SEN Expert Group 2. Their appointments reflect the Philippines' active role in addressing maritime education, training, and seafarer welfare at the international level.

The meetings gathered policymakers and experts from the APEC Transportation Working Group (TPTWG), Maritime Expert Group (MEG), and APEC SEN Steering Council to discuss pressing global maritime issues. Day one focused on navigation technology and the development of marine engineers, addressing the skills required for future seafarers, including education for autonomous vessels.



On the second day, Expert Group 1 examined challenges in maritime education and training, particularly in the context of emerging technologies and new standards. Topics included recent changes in seafarer employment, updates on the Korean ODA capacity-building program, and the transition to sustainable maritime human resources.

The final day highlighted discussions in Expert Group 2, which centered on improving the job appeal and rights of seafarers in the Asia-Pacific region. Issues like ambulance chasing in the Philippines, advancements in maritime labor rights, and the impact of COVID-19 on maritime transport were also addressed. Through MARINA's proactive international engagement, the Philippines remains committed to the professional growth and welfare of its seafarers.



IFETAS, initiated by the Republic of Korea (RoK), brings together key stakeholders from seafaring nations, international maritime organizations, and research institutions to address the evolving landscape of maritime mobility. The forum aims to challenges arising from rapid technological advancements and the global shift toward environmental sustainability, particularly within the maritime industry.

The forum's discussions highlighted emerging technologies, including AI-powered digital ships and Maritime Autonomous Surface Ships (MASS). Additionally, participants explored the global transition to a green supply chain, aligned with the International Maritime Organization's (IMO) 2050 Net-Zero Strategy. These advancements emphasize the need for a shift in maritime education and training to equip seafarers with the skills required for operating these high-tech vessels.

The Republic of Korea, in collaboration with its international partners, is working to establish a global platform for training seafarers to safely operate advanced ships. The forum emphasized the importance of international cooperation, the development of a global training framework, and securing funding for projects aimed at preparing a skilled maritime workforce for the future.



The event gathered participants from key organizations, including the Korea Maritime Institute, Korea Research Institute of Ships and Ocean Engineering, and Korea Maritime & Ocean University. The forum concluded with the signing of a letter of intent, affirming the commitment of all participants to foster global collaboration in advancing maritime mobility.

Administrator Malaluan Advocates Continuous Learning for Seafarers at DMW Job Fair

MARINA Administrator Sonia B. Malaluan emphasized the importance of continuous learning for Filipino seafarers during the Department of Migrant Workers' (DMW) "Disenteng Trabaho para sa mga Marinong Filipino Mega Job Fair" on 22 September 2024. The event, held at the SMX Convention Center in Pasay City, celebrated National Maritime Week and National Seafarers Day, offering over 3,000 employment opportunities from licensed manning agencies (LMAs).

In her address, Administrator Malaluan encouraged seafarers to embrace advancements like automation, digitalization, and decarbonization, noting that younger generations are



well-equipped to adapt to these changes. She also highlighted the importance of proper training, especially with the introduction of alternative fuels in the maritime industry, advising officers to be fully prepared before boarding.

discussions on the STCW Convention continue, Administrator Malaluan reaffirmed her commitment to aligning training programs with the actual needs of seafarers, ensuring they remain competitive in the global market. During the event, she engaged with applicants to address concerns about the processing of COPs, COCs, SRBs, and SIDs, vowing to address delays in the issuance of SRBs.

MARINA Presents Draft Papers for STCW Convention Revision

PASAY CITY – The Maritime Industry Authority (MARINA), through its STCW Office, hosted the "Usapang STCW" forum on 04 September 2024, as part of its preparations for the upcoming revision of the STCW Convention. The forum focused on discussing five draft papers that the Philippines plans to submit to the International Maritime Organization (IMO), gathering insights from key maritime stakeholders. This initiative underscores the country's efforts to ensure that the revised convention addresses both current challenges and future developments in the maritime industry.

The draft papers reflect the Philippines' commitment to contributing meaningfully to the global maritime framework.
MARINA STCW Office Executive Director Samuel L. Batalla
emphasized the importance of inclusivity and forward-thinking in the revision process, ensuring that the new standards cater to the evolving needs of seafarers and the maritime community at large.

"We are committed to contributing to a Convention that is not only a regulatory framework but also a tool for empowerment, enabling not only our seafarers but all maritime industry stakeholders to thrive in a dynamic and challenging future," Executive Director Batalla stated. He encouraged all participants to provide input that would shape a convention tailored to the realities of the maritime industry, both all lines. tailored to the realities of the maritime industry, both globally and in the Philippines.

During the event, STCW Office MET Standards Supervisor Presca Lee B. Lugo facilitated discussions on the draft papers. The morning session opened with Maritime Industry Development Specialist Margie M. Mataac presenting the first paper on the digitalization of documentation, including STCW certificates. This was followed by MET Standards Supervisor Capt. Ronald Sediego's presentation on reducing onboard training requirements, with a focus on advanced simulatorbased training to improve efficiency.

In the afternoon, ISWAN Country Manager Marville Cullen Espago addressed seafarer welfare issues, particularly workplace violence and harassment. MET Standards Supervisor C/E Charlie M. Pandongan presented a paper on the qualifications of seafarers aboard ships subject to the IGF Code. The final presentation by MET Standards Supervisor Herbert V. Nalupa highlighted the need to harmonize gaps between Regulation I/10 and Regulation I/2 for better implementation. The forum concluded with representatives from government agencies, Maritime Higher Education Institutions, Maritime Training Institutions, and other industry partners contributing valuable feedback, ensuring the Philippines plays a proactive role in shaping global maritime regulations.





MARINA welcomes first foreign-owned shipping company in the Philippines

The Maritime Industry Authority (MARINA) welcomed the first foreign-owned shipping company in the Philippines.

Under its flagship intra-Asia brand CNC, the CMA CGM Group launched the CMA CGM Philippines Shipping (CCPS) as the first 100% foreign-owned shipping company registered by the Securities and Exchange Commission (SEC) that will provide domestic shipping service in the country. The CNC Pilipinas, first Philippine-flagged vessel in the CMA CGM fleet, has a capacity to carry 1,037 twenty-foot equivalent units (TEUs) would serve weekly via Luzon Visayas Mindanao Express (LVMX), with port rotation Manila-Cagayan De Oro-Cebu-Manila.

The MARINA led by Administrator Sonia Malaluan expressed its support to the CCPS during its inauguration ceremony held at Hilton Hotel, Pasay City on 27 September 2024. Malaluan highlighted that the Agency welcomes new players such as CMA CGM in the country especially with the amendment of RA 11659 otherwise known as Public Service Act, which allows 100 percent foreign ownership. She said that MARINA believes that this development will lead to attracting more investments and

level up the competition in the maritime sector. The Administrator added that they expect bigger, better, greener and safer ships in the domestic shipping following the entry of the CMA CGM Philippines, as well as more job opportunities for Filipino seafarers and reduced transport cost in the future.

Undersecretary for Maritime Elmer Francisco Sarmiento said that the government focuses on safety, decarbonization and innovation through digitalization, which is consistent with the Maritime Industry Development Plan (MIDP) 2028. He emphasized that safety is the main priority and the Department of Transportation (DOTr) is confident that CNC will be a core partner in promoting a safety culture and green shipping in the country. Usec. Sarmiento believes that CNC will lead the way in decarbonizing sea transport in line with the goal of complying with the IMO GHG strategy.

The CNC Philippines Domestic Shipping Service Launch was also attended by CMA CGM Asia Pacific CEO Bo Wegener, CNC CEO Steven Zhu, French Ambassador H.E. Marie Fontanel and other MARINA officials among others.

MARINA Harmonizes Strategic Plans for 2025 to Enhance Maritime Industry Initiatives



The Maritime Industry Authority (MARINA) held a strategic planning workshop focused on harmonizing key plans for Fiscal Year 2025 from 02-04 September 2025.

MARINA Chief Presents Investments Opportunities to European Chambers


The Maritime Industry Authority (MARINA) presented various investment opportunities in the Philippine maritime industry to different European chambers of commerce and industry.

During the Joint Maritime Committee (JMC) Meeting, MARINA Administrator Sonia Malaluan discussed the Maritime Industry Development Plan (MIDP) 2028, as well as the respective legislative agenda and high impact projects for each MIDP program. The event was held at German Club Manila in Makati City on 29 August 2024, and it was facilitated by JMC Chairperson Mr. Tore Henriksen.

Malaluan presented the 10-point agenda under her administration and the highlights of accomplishments during first quarter of the year. Aside from MIDP 2028, she provided updates on the rollout of MARINA Blockchain Enabled Automated Certification System (BEST); the efforts in relation to the Agency's goal in expanding its ISO 9001:2015 certification; bilateral agreements on recognition of STCW certificates; as well as various partnership with concerned government agencies and relevant maritime stakeholders.

Among other accomplishments that were presented are programs related to enhancing maritime safety; the inclusion of the Philippines in the "IMO Whitelist," which recognized the country's commitment to maintaining high standards in maritime education, training, and certification for seafarers; the proposed policy on operational flexibility; capacity building and cooperation on alternative fuels; and the respective Bills that aim to improve ship registry and shipbuilding and ship repair sector.

The Administrator was accompanied by MARINA Planning and Policy Service Director Luisito delos Santos. The said meeting was also attended by German-Philippine Chamber of Commerce, Nordic Chamber of Commerce, French Chamber of Commerce, Dutch Chamber of Commerce and Philippine-Norway Business Council among others.



MARINA participates in 31st Marine Accident Investigators' International Forum



Maritime Industry Authority-Enforcement (MARINA-ES) participated in the 31st Session of the Marine Accident Investigators' International Forum (MAIIF31) held in Beijing, China from 23-27 September 2024.

The event emphasized the importance of international collaboration in marine casualty investigations and maritime safety.

Representing the Philippines were Engr. Ronaldo P. Bandalaria, MARINA ES Director, and Engr. Gielver M. Castillo, Senior MIDS. The forum brought together 29 countries from Europe, Asia, America, and Africa to enhance cooperation and share expertise in marine safety investigations.

During the forum, the Philippine delegation presented insights from the recently concluded Marine Accident Investigators' Forum in Asia (MAIFA24), held in Boracay, Aklan. Discussions also covered each country's progress in maritime safety investigations, a review of the MAIIF charter, and plans for future collaboration.

The event focused on sharing best practices and the outcomes of various marine safety investigations, highlighting the importance of training and continuous professional development for investigators.









ASEAN Adopts Regional Strategy on Biofouling Management to Protect Marine Ecosystems

The ASEAN Member States adopted the Regional Strategy on Biofouling Management during the 47th ASEAN Maritime Transport Working Group (MTWG) meeting in Brunei Darussalam, held from 17 to 18 September 2024. This strategy aims to enhance biofouling management practices across the region to protect marine ecosystems and improve the energy efficiency of ships.

Led by MARINA Deputy Administrator for Operations, Ms. Nannette V. Dinopol, the Philippine delegation presented the draft strategy. The initiative, a collaboration between the Philippines, Indonesia, the International Maritime Organization (IMO), and PEMSEA, demonstrates a collective commitment to sustainable maritime operations and marine ecosystem preservation.

The strategy's adoption opens opportunities for capacity-building among ASEAN Member States, with the Philippines and Indonesia promoting regional cooperation on biofouling management. This effort is supported by the IMO and PEMSEA, fostering coordinated action at the ASEAN level.

The Philippines expressed gratitude to ASEAN dialogue partners and the European Union for their support in capacity-building and technical assistance, which have helped the country comply with maritime conventions.

The Philippine delegation included representatives from the Department of Transportation (DOTr), MARINA, the Philippine Coast Guard (PCG), and the Philippine Ports Authority (PPA).

MARINA Takes Part in WIMA Asia Regional Conference to Boost Women's Maritime Leadership



The Maritime Industry Authority (MARINA) took an active role in the Women in Maritime Association (WIMA) Asia Regional Conference held from 10-12 September 2024. Themed "Tides and Change: Women Leading to a Sustainable and Innovative Maritime Future," the conference was organized by the International Maritime Organization (IMO) and Women in Maritime Association - Korea (WIMA-Korea). It aimed to address the challenges women face in the maritime industry and empower them through education and collaboration.

MARINA Administrator Sonia B. Malaluan highlighted the Philippines' leadership in the maritime sector, with a strong focus on digitalization and decarbonization. She introduced MARINA's "Charting a Clean Course" campaign, emphasizing responsible governance and sustainability. Malaluan also showcased digital innovations like the MARINA Integrated Seafarers Management Online (MISMO) System and the Blockchain Enabled Automated Certification System (MARINA-BEST), both designed to enhance efficiency and transparency in maritime operations.

In addition to digitalization, Malaluan discussed MARINA's efforts in reducing greenhouse gas emissions through the development of a National Strategy and Action Plan on decarbonization. She stressed the importance of partnerships with government and industry stakeholders to ensure the effective implementation of these initiatives, further strengthening MARINA's role in driving industry-wide reforms.

Atty. Sharon D. Aledo, MARINA's Director for Legal Service, contributed to the discussions as a panelist, focusing on the evolving leadership roles of women in the Asian maritime sector. She emphasized the importance of inclusivity, collaboration, and the crucial role of women in driving innovation, while addressing the challenges posed by gender stereotyping in the industry.

The conference gathered representatives from various sectors, including private companies and government agencies, from across the region.

MARINA Hosts Maifa24 to Enhance Maritime Safety Cooperation

Malay, Aklan - The Maritime Industry Authority (MARINA), through its Enforcement Service (ES), successfully hosted the Marine Accident Investigators' Forum in Asia 2024 (MAIFA24) from 4-6 September 2024. The event aimed to strengthen collaboration and improve maritime safety by bringing together international delegates and marine investigators from across the region.

In her opening remarks, MARINA Administrator Sonia B. Malaluan emphasized the significance of proactive discussions during the forum, highlighting MAIFA's role in fostering a progressive and collaborative spirit in the maritime sector. She underscored the importance of continuous cooperation to enhance safety practices in the industry.

Throughout the three-day forum, delegates exchanged insights and presented case studies on critical maritime incidents, such as ship sinkings, collisions, capsizing, occupational accidents, and onboard fires. The event provided a platform for sharing best and new methodologies in marine

investigations. Key updates on the Comprehensive Review of the Casualty Investigation Code and findings from the International Maritime Organization (IMO) Member State Audit Scheme (IMSAS) were also discussed.

One of the highlights of MAIFA24 was the formal inclusion of Saudi Arabia as the forum's 15th member, further expanding the organization's international scope. The event was attended by representatives from 11 member states, including Australia, China, Hong Kong, Indonesia, Japan, Korea, New Zealand, Singapore, Thailand, the Philippines, and Malaysia. Observers from France, Denmark, the Marshall Islands, and Saudi Arabia also participated, alongside local stakeholders like the Filipino Shipowners Association and the Philippine Coast Guard.

The forum concluded with a renewed commitment to international cooperation in marine accident investigations, aiming to create safer seas across the region. Singapore was announced as the host for the next MAIFA in 2025.







MARINA Concludes 3rd Capacity Building Workshop on Marine **Casualty Investigation**

MANILA CITY- The Maritime Industry Authority (MARINA), through its Enforcement Service, concluded the third batch of its "Capacity Building Workshop on the Conduct of Marine Casualty Investigations," held from 16-20 September 2024.
