**RESOLUTION RECOMMENDING THE APPROVAL OF
ADDITIONAL/MODIFICATION REQUIREMENTS OF THE
MARINA CENTRAL OFFICE AS SUPPLEMENTAL TO
THE ANNUAL PROCUREMENT PLAN FOR FY 2025**

WHEREAS, Section 7.1, Rule II of the of the 2016 Revised Implementing Rules and Regulations (R-IRR) of the Republic Act (RA) No. 9184 or the Government Procurement Reform Act states that “All procurement shall be within the approved budget of the Procuring Entity and should be meticulously and judiciously planned by the Procuring Entity;

WHEREAS, Section 7.2, Rule II of the R-IRR of RA No. 9184 states that “No procurement shall be undertaken unless it is in accordance with the approved Annual Procurement Plan (APP), including approved changes thereto. The APP must be consistent with the duly approved yearly budget of the Procuring Entity and shall bear the approval of the Head of the Procuring Entity (HoPE) or second-ranking official designated by the HoPE to act on his behalf;

WHEREAS, Section 7.4, Rule II of the R-IRR of RA No. 9184 states that “Changes to the individual PPMPs and the consolidated APP may be undertaken every six (6) months or as often as may be required by the HoPE. The respective end-user or implementing units of the Procuring Entity shall be responsible for the changes to the PPMPs, while the BAC Secretariat shall be responsible for the consolidation of these PPMPs into an APP, which shall be subject to the approval of the HoPE.”;

WHEREAS, the Supplemental Procurement Management Plan for the Procurement of various projects and activities relative to the Hosting of the International Conference on Seafarers' Human Rights, Safety and Wellbeing scheduled on 01-03 September 2025, has been submitted to the Procurement Division of the Management, Financial and Administrative Service (MFAS) for inclusion into the FY 2025 APP;

WHEREAS, in compliance with the aforementioned provisions, the Procurement Division of MFAS has prepared the **Supplemental APP No. 5**;

WHEREAS, the approved FY 2025 APP including Supplemental APP Nos. 1, 2, 3, 4 and No. 5 reflects the procurement activities to be undertaken by the MARINA Central Office within the calendar year, and shall serve as basis for the procurement implementation, whereby only the projects and activities included therein shall be carried out through competitive bidding or alternative modes of procurement;

WHEREFORE, in light of the foregoing considerations, the members of the Bids and Awards Committee RESOLVES, as it hereby RESOLVED, to recommend to the Administrator as the HoPE, the approval of the **Supplemental APP No. 5 for FY 2025**, to incorporate various projects and activities relative to the Hosting of the International Conference on Seafarers' Human Rights, Safety and Wellbeing scheduled on 01-03 September 2025 under the approved FY 2025 Annual Procurement Plan.
