

PROCUREMENT OF AIR TRAVEL MANAGEMENT SERVICES FOR THE SECRETARY GENERAL OF THE INTERNATIONAL MARITIME ORGANIZATION (IMO), ARSENIO DOMINGUEZ TO ATTEND THE PHILIPPINES' HOSTING OF THE REGIONAL FORUM ON THE EFFECTIVE IMPLEMENTATION OF THE STCW CONVENTION CODE IN MANILA FROM 17 TO 19 FEBRUARY 2026

CONTRACT AGREEMENT

This Agreement is made and entered into on this 11 FEB 2026 day of February 2026 by and between:

MALALUAN, hereinafter referred to as the "PROCURING ENTITY";

WHEREAS, the Entity invited Quotations for certain goods and ancillary services, particularly Air Travel Management Services Air Travel Management Services for the Secretary General of the International Maritime Organization (IMO), Arsenio Dominguez to Attend the Philippines' Hosting of the Regional Forum on the Effective Implementation of the STCW Convention Code in Manila from 17 To 19 February 2026 and has accepted a Quotation by the Supplier for the supply of those goods and services in the sum of *One Million Two Hundred Twenty-Three Thousand Seven Hundred Fifty Pesos (P1,223,750.00), inclusive of all taxes and charges* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this contract, words and expressions shall have the same meaning as they are used in the Technical Specifications.
 2. The following accreditation and compliance requirements as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. The Service Provider is an accredited International Air Transport Association (IATA) Travel Agency duly licensed in the Philippines;
 - b. The Service Provider has good track record of providing events requirements to international organizations and global events evidenced by certificates of recognition, awards, letter of recommendations or equivalent document from previous clients or organizations;
 - c. The Service Provider is Department of Tourism (DOT) accredited;
 - d. The Service Provider submitted the following documentary requirements:
 - i. Accomplished Request for Quotations;
 - ii. a valid PhilGEPS Registration;

- iii. a valid Mayor's/ Business Permit;
 - iv. a valid Income Tax Return (ITR)/ Tax Clearance;
 - v. a valid DTI/SEC Certificate of Registration;
 - vi. a Notarized Omnibus Sworn Statement:
- e. Notice of Award of Contract; and the Supplier's conforme thereto; and
- f. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the RFQs. **Winning Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, and Variation Orders, shall likewise form part of the Contract.**
3. In consideration for the sum of *One Million Two Hundred Twenty-Three Thousand Seven Hundred Fifty Pesos (₱1,223,750.00)*, inclusive of all taxes and charges or such other sums as may be ascertained, *CHASE WONDER TRAVEL ATELIER CORP.* agrees to *Air Travel Management Services Air Travel Management Services for the Secretary General of the International Maritime Organization (IMO), Arsenio Dominguez to Attend the Philippines' Hosting of the Regional Forum on the Effective Implementation of the STCW Convention Code in Manila from 17 To 19 February 2026* in accordance with its Quotations.
4. The *Procuring Entity* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The Procuring Entity shall book additional tickets beyond the ABC, not exceeding twenty percent (20%), subject to the approval of the Head of Procuring Entity (HoPE). The same pricing structure and service terms shall apply.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


