RESOLUTION RECOMMENDING THE APPROVAL OF THE
MARITIME INDUSTRY AUTHORITY'S
INDICATIVE ANNUAL PROCUREMENT PLAN
FOR THE FISCAL YEAR 2027

WHEREAS, Section 7.7 of Republic Act No. 12009, otherwise known as the New Government Procurement Act, and its Implementing Rules and Regulations (IRR) mandate that all procurement shall be undertaken only within the approved budget of the Procuring Entity, and that only projects crucial to the efficient discharge of agency functions shall be included in the Annual Procurement Plan (APP) for planning and budgeting purposes;

WHEREAS, pursuant to Sections 7.7.1 to 7.7.5 of the IRR of RA 12009, the End-Users or Implementing Units are required to prepare their respective Project Procurement Management Plans (PPMPs) covering their programs, activities, and projects (PAPs), indicating whether procurement is required, the type and objective of the project, quantity, procurement modality, schedule, estimated budget, and technical specifications or terms of reference;

WHEREAS, the Indicative PPMPs submitted by the End-User Units have been evaluated by the Management, Financial and Administrative Service - Budget Division and consolidated by the BAC Secretariat into the Indicative Annual Procurement Plan (IAPP) for FY 2027, consistent with the agency's proposed budget ceiling and operational priorities;

WHEREAS, the BAC Secretariat has ensured that the consolidated IAPP includes the required details under Section 7.7.2 of the IRR of RA 12009, such as project name, end-user, description, procurement mode, bid evaluation criteria, schedule of activities, source of funds, ABC, and other relevant procurement strategies;

WHEREAS, the BAC, upon review, finds the consolidated IAPP for FY 2027 to be complete, compliant, and responsive to the operational requirements of MARINA;

NOW, THEREFORE, in light of the foregoing considerations, the members of the Bids and Awards Committee **RESOLVE**, as it hereby **RESOLVED**, to recommend to the
